Disinfects, Daily Cleans & Rinses

DIRECTIONS: TO OBTAIN DISINFECTION THESE STEPS MUST BE COMPLETED:

STEP 1:

Place at least 3 drops of **ReNu® Multi-Purpose Solution** on each side of contact lens and rub for 20 seconds. No separate daily cleaner necessary.

STEP 2:

Remove surface debris by rinsing thoroughly with **ReNu Multi-Purpose Solution**.

STEP 3:

Place cleaned contacts in lens case and fill with fresh **ReNu Multi-Purpose Solution**. Soak for at least four hours.

Lenses may be stored in the unopened case until ready to wear, up to a maximum of 30 days. If you store your lenses for longer periods of time, they must be cleaned and disinfected with fresh **ReNu Multi-Purpose Solution** every 30 days and prior to wearing.

Your lenses are now ready to wear. No saline rinse necessary. If any debris remains on contacts, rinse with **ReNu Multi-Purpose Solution** prior to insertion.

If not wearing contacts immediately, store in unopened lens case. Do not store your lenses in ordinary saline in place of **ReNu Multi-Purpose Solution**. Saline solution will not disinfect.

TO REMOVE PROTEIN FROM YOUR CONTACTS:

The special combination of **ReNu Multi-Purpose Solution** with **ReNu 1 Step™ Daily Protein Remover Liquid** is a simple and convenient way to effectively remove protein deposits from soft contact lenses on a daily basis. **ReNu 1 Step Daily Protein Remover Liquid** is especially formulated for daily use to simultaneously enzymatically clean and disinfect your lenses every time you soak your lenses in **ReNu Multi-Purpose Solution**.

FOLLOW DIRECTIONS PROVIDED WITH THE ENZYMATIC CLEANER AND USE AS DIRECTED BY YOUR EYE CARE PROFESSIONAL.

Note: Proper lens care requires removal of protein deposits from your lenses.

CONTENTS:

A sterile, isotonic solution that contains boric acid, edetate disodium, poloxamine, sodium borate and sodium chloride; preserved with **DYMED®** (polyaminopropyl biguanide) 0.00005%.

ACTIONS:

Cleans, loosens and removes accumulations of film, deposits and debris from soft contact lenses. Destroys harmful micro-organisms on the surface of the lens. Rinses, stores and rewets lenses before insertion. **For use in combination with ReNu 1 Step Daily Protein Remover Liquid.**

INDICATIONS (Uses):

Bausch & Lomb ReNu Multi-Purpose Solution is indicated for use in daily cleaning, protein removal when used with **ReNu 1 Step Daily Protein Remover Liquid**, rinsing and storage of daily and extended wear soft contact lenses and chemical (not heat) disinfection, as recommended by your eye care professional.

CONTRAINDICATIONS (Reasons not to use):

If you are allergic to any ingredient in **Bausch & Lomb ReNu Multi-Purpose Solution**, do not use this product.

WARNINGS: PROBLEMS WITH CONTACT LENSES AND LENS CARE PRODUCTS COULD RESULT IN SERIOUS INJURY TO THE EYE.

It is essential that you follow your eye care professional's directions and all labeling instructions for proper use and care of your contact lenses and lens care products, including the lens case. Eye problems, including corneal ulcers, can develop rapidly and lead to loss of vision. Daily wear lenses are not indicated for overnight wear and should not be worn while sleeping. Clinical studies have shown the risk of serious adverse reactions is increased when these lenses are worn overnight. Extended wear lenses should be regularly removed for cleaning and disinfection or for disposal and replacement on the schedule prescribed by your eye care professional.

Clinical studies have shown that there is an increased incidence of serious adverse reactions in extended wear contact lens users as compared to daily wear contact lens users. Studies have also shown that the risk of serious adverse reactions increases the longer extended wear lenses are worn before removal for cleaning and disinfection or for disposal and replacement. Studies have also shown that smokers have a higher incidence of adverse reactions. If you experience eye discomfort, excessive tearing, vision changes, redness of the eye, immediately remove your lenses and promptly contact your eye care professional. It is recommended that contact lens wearers see their eye care professional twice each year or, if directed, more frequently.

- To avoid contamination, do not touch tip of container to any surface. Replace cap after using.
- Not for use with heat (thermal) disinfection.

PRECAUTIONS:

- Never re-use this solution.
- Keep the bottle tightly closed when not in use.
- Store at room temperature.
- Use before the expiration date marked on the carton and bottle.
- Keep out of the reach of children.

ADVERSE REACTIONS (Problems and what to do):

The following problems may occur: eyes sting, burn or itch (irritation), comfort is less than when lens was first placed on the eye, feeling of something in the eye (foreign body, scratched area), excessive watering (tearing) of the eye, unusual eye secretions, redness of the eye, reduced sharpness of vision (poor visual acuity), blurred vision, rainbows or halos around objects, sensitivity to light (photophobia), or dry eyes.

If you notice any of the above:

IMMEDIATELY REMOVE YOUR LENSES.

- If the discomfort or problem stops, then look closely at the lens.
- If the lens is in any way damaged, **DO NOT** put the lens back on your eye. Place the lens in the storage case and contact your eye care professional.
- If the lens has dirt, an eyelash, or other foreign body on it, or the problem stops and the lens appears undamaged, thoroughly clean, rinse and disinfect the lens, then reinsert it.
- If the problem continues, **IMMEDIATELY** remove the lens and consult your eye care professional.

If any of the above symptoms occur, a serious condition such as infection, corneal ulcer, neovascularization or iritis may be present. Seek immediate professional identification of the problem and prompt treatment to avoid serious eye damage.

GOOD LENS CARE PRACTICES:

- Always wash and rinse your hands before you handle your lenses.
- Clean, rinse and disinfect your lenses each time you remove them.
- Always handle the same lens, the right or the left, first in order to avoid mix-ups.
- After use, always empty and rinse lens case with fresh **ReNu Multi-Purpose Solution**, and allow to air dry.
